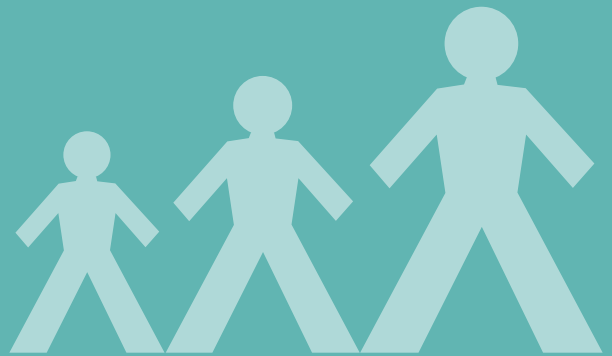


Organisational Membership

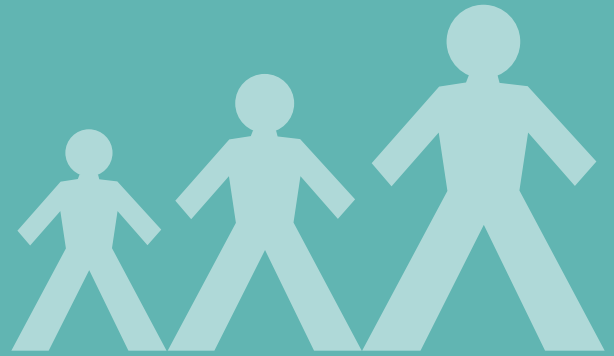
