

Euclidian Benefits for Parliament is a web-based interactive learning tool designed as a standard national on-line induction programme into Housing Benefit and Council Tax Benefit. The course provides Members of Parliament with an understanding of all aspects of Housing Benefit and Council Tax Benefit.

Euclidian Benefits Basics has three key areas:

1. Personal Profile

Allows the learner to plot a personal route through the programme by identifying the learning style which best suits them.

2. Learning Centre

Provides a comprehensive range of learning activities designed to accommodate a range of learning styles.

3. Resource Centre

Acts as the programme library where learners can view important content from the Learning Centre and link to essential legislation, documents and websites.

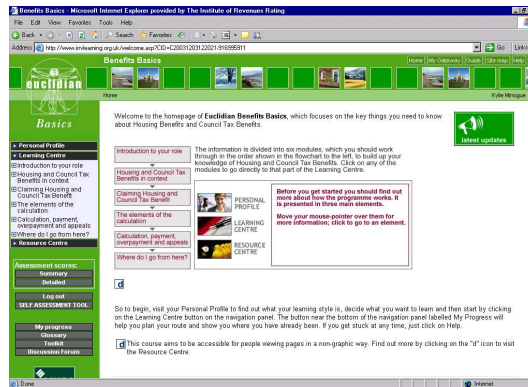
